PERFORMANCE IS WITH A BAND, THE
PURCHASER AGREES TO PROVIDE ALL RELEVANT
EQUIPMENT REQUIRED FOR THE ARTIST
AND THE BAND

STAGE REQUIREMENTS

The Stage shall be of safe, solid construction, and be level so as not to
hinder free movement of equipment and personnel. Stage should be
clear of any equipment not being used in conjunction with ARTIST'S
show.



UNSAFE CONDITIONS:

The ARTIST shall have the right to refuse to perform if performance conditions unsafe. Despite such refusal to perform, The ARTIST shall be paid full contracted price as shown of the face of contract.

Return of Rider/Contract

PURCHASER agrees to sign and return this Rider and Contract to the Artist agent, within fourteen (14) days from the issue date of the Contract; otherwise, The Artist shall have the right to cancel the Engagement upon notice thereof without liability. The Artist's failure to exercise its right to cancel the Engagement upon the completion of said fourteen (14) day period should not be deemed a waiver of the Artist's right to cancel the Engagement at any time thereafter.

MODIFICATION/ASSIGNMENT/MISCELLANEOUS

This Rider and Contract is the sole and complete agreement between the parties with respect to the Engagement and supersedes all prior and contemporaneous agreements regarding the subject matter hereof. This Rider and Contract (or any part thereof) may not be changed, modified, or waived except by a signed, written agreement of the parties. Nothing in this Rider or Contract shall require the performance of any act contrary to the law or to the rules or regulations of any union, guild, or similar body having jurisdiction over the services of ARTIST or the Engagement. Whenever there is any conflict between any provisions of this Rider and Contract and any law, rule, or regulation, said law, rule, or regulation shall prevail, and this Rider and Contract shall be modified to the extent



necessary to eliminate such conflict. This Rider and Contract may not be assigned without the written agreement of the parties; otherwise, any such attempted assignment shall be deemed null and void.

All Billing/Advertising:

In all news released, announcements, advertisements, posters and printed programs relative to this engagement, the billing must read: "JUDAH BROWNNY".

The artist photo should also be added to any agreed promotional posters, flyers and documents. (photo can be provided at the request of PURCHASER)
